Information on settlement application process for refugees resettled under the Vulnerable Persons and Vulnerable Children's Resettlement Schemes

June 2019

If you are a refugee who has been resettled under the Vulnerable Persons or Vulnerable Children's Resettlement schemes, you will usually have been granted five years limited leave to remain in the UK.

After five years in the UK, you may be entitled to apply for settlement in the UK and if your application is successful, you will be granted indefinite leave to remain (ILR) in the UK. Once you have ILR, you may meet the requirements to apply to become a British citizen after a further 12 months.

The following family members can be included in the same application:

- Your spouse (husband or wife) and children (aged under 18) if they were resettled to the UK at the same time as you;
- Any family members granted leave to remain in the UK as your dependant under the family reunion route.

Any other family members will need to make their own application at the relevant time.

You should apply during the last month of your current permission to be in the UK. It is important that you apply for settlement before your leave to remain expires so that you do not end up in the UK without permission. Not applying for settlement and overstaying may negatively impact your ability to stay in the UK.
